5 events have been carried out within this project:

Event 1

Participation: The event involved 13 citizens, including participants from the Warsaw (**Poland**), Lyon (**France**), Skopje (**the Republic of Macedonia**), Sopron and Budapest (**Hungary**), Frankfurt (**Germany**), Bologna and Modena (**Italy**), Donostia-San Sebastian (**Spain**)

Location / Dates: The event took place in The Hague (**The Netherlands**), from 02/10/2015 to 04/10/2015

Short description: The aim of the event was to allow the core team members to get to know each other and agree on clear lines of management and communication for the whole project. The meeting also allowed participants get a clearer vision of the project process and time plan, and how they will individually contribute. Participants were also introduced to Historiana and the capacity for learning activities and sources.

Event 2

Participation: The event involved 27 citizens, including participants from the Warsaw (**Poland**), Lyon (**France**), Skopje (**the Republic of Macedonia**), Sopron and Budapest (**Hungary**), Frankfurt (**Germany**), Bologna and Modena (**Italy**), Donostia-San Sebastian (**Spain**).

Location / Dates: The event took place in Bologna (**Italy**), from 22/01/2016 to 24/01/2016

Short description: The aim of the event to present the selection of sources identified for each enquiry questions agreed in the kick-off meeting in The Hague (October 2015), collecting feedback and suggestions of the project team on further development of draft materials, piloting draft materials among local educators through an active workshop and collecting feedback on the content and use of the source materials and eventually agreeing on the next steps and framework of the development of the educational material.

Event 3

Participation: The event involved 26 citizens, including participants from the Warsaw (**Poland**), Lyon (**France**), Skopje (**the Republic of Macedonia**), Sopron and Budapest (**Hungary**), Frankfurt (**Germany**), Bologna and Modena (**Italy**), Donostia-San Sebastian (**Spain**).

Location / Dates: The event took place in Budapest (**Hungary**), from 10/06/2016 to 12/06/2016

Short description: The aim of the event was to pilot draft source materials and to receive external feedback from local teachers and internal feedback from the core members of the project, in order to improve the continuing development of materials. In addition, an aim of the meeting was to discuss the further development of the various elements of the project, to update the team members on the work everyone has been doing, and to divide tasks on the further development of other aspects of the project among the team members.

Event(s) 4

Participation: The event(s) involved 762 citizens, including 64 participants from the city of Lyon (**France**); 56 participants from the city of Frankfurt (**Germany**); 125 participants from the city of Modena and Bologna (**Italy**); 83 participants from the city of Sopron (**Hungary**); 98 participants from the city of Ohrid and Skopje (**the Republic of Macedonia**); 21 participants from the city of Belfast (**Northern Ireland**); and 159 participants from the city of Eskoriatza, Santo Tomas, Arizmendi, Andoain, Bilbao and Donostia-San Sebastian (**Spain**).

Location / Dates: The event(s) took place in Lyon (**France**); Frankfurt (**Germany**); Sopron (**Hungary**); Bologna and Modena (**Italy**); Ohrid and Skopje (**the Republic of Macedonia**); Eskoriatza, Santo Tomas, Arizmendi, Andoain, Bilbao and Donostia-San Sebastian (**Spain**); and Belfast (**Northern Ireland**), from 23/01/2016 to 07/04/2017

Short description: The aim of the event(s) was the testing and development of learning activities and source materials. A rigorous review process to ensure the diverse range of sources and methods used serve to motivate students to choose to work with the sources that excites or interests them most. All resources within the unit are designed to reinforce cross-border learning and teaching of Europe's totalitarian past, and to promote active learning methods applied to history and citizenship.

Event 5

Participation: The event involved 26 citizens, including participants from the Warsaw (**Poland**), Lyon (**France**), Skopje (**the Republic of Macedonia**), Sopron and Budapest (**Hungary**), Frankfurt (**Germany**), Bologna and Modena (**Italy**), Donostia-San Sebastian (**Spain**).

Location / Dates: The event took place in Skopje (**the Republic of Macedonia**), from 01/12/2016 to 04/12/2016

Short description: The final development meeting had several aims. In addition to meeting and reviewing materials, the group conducted a workshop with the draft materials the project team have developed among local teachers and received feedback on these materials. Moreover, the Skopje meeting allowed the team to work on and improve learning activities and source collections, as well as discuss the further development of the elements in the project. Finally, the team members updated each other of the work everyone has been doing and divided

tasks for the development of other aspects of the project. Additionally, the participants had to start strategizing and thinking about the final training seminar that will be held during the EUROCLIO Annual Conference in San Sebastian in April 2017.
