1. Introduction

EuroClio, the European Association of History Educators, is a non-profit civil society organisation established in 1992. Its core mission is to support the development of responsible and innovative history, heritage, and citizenship education by promoting critical thinking, mutual respect, peace, stability and democracy. EuroClio holds official UNESCO NGO status and is a member of the Conference of INGOs of the Council of Europe, the DARE Network, and the Lifelong Learning Platform.

The Association counts 74 volunteer history, heritage and citizenship educators' associations and related institutes from 45 mostly European countries and connects around 30,000 professionals, who in their daily work are in contact with more than 4,000,000 students per year. The Secretariat, which has 6 staff members, is supervised by the democratically elected EuroClio Board of 6 members, and frequently advised by a wide range of experts in the networks the organisation has. In 2023 EuroClio involved more than 320 people as an ambassador, author, coordinator, editor, editor-in-chief, facilitator, mentor, staff member, reviewer or trainee. Through all its activities, the Association engaged more than 1.000 education professionals from Europe and beyond.

2. Governance and Management

EuroClio is a not-for-profit organisation under Dutch Law, headquartered in The Hague. EuroClio is recognized by the tax authorities in the Netherlands as a charitable, so-called "ANBI", organisation.

The General Assembly

Is the highest governing body of EuroClio. It discusses and approves the annual report, the financial report, budgets, decides on the statutes and internal rules of EuroClio, and elects and discharges Board and Audit Committee Members. The General Assembly meets at least once a year, typically during the Annual Conference of EuroClio.

3. Projects and partnerships

EuroClio worked on several projects and partnerships in 2023 to advance its mission.

The projects:

- History Education Beyond Borders III is a project supported by the Northeast Asian History Foundation which brought together experts on the development of cross-border history education resources to exchange best practices and create an updated set of recommendations, a set of training materials, and a documentary video on the development of cross-border history education resources. In 2023, we held an expert meeting in Seoul, bringing together historians and history educators from China, Japan and South Korea, and submitted the first draft for a chapter using travelogues as sources to learn and teach about Northeast Asian history.
- Learning a History that is not yet History II is a project in which history educators from the former Yugoslav region are working on ready-to-use learning activities and a teachers' guide for responsible teaching of the wars in Yugoslavia and its successor states. The project was awarded the Global Pluralism Award in 2019 and is being supported by the Dutch Ministry of Foreign Affairs since 2021. In 2023, the team developed 1 and edited 16 learning activities on the topic of recent history in the Balkans based on the piloting and peer-review. The team of authors for the Toolkit for Teaching Sensitive and Controversial Topics completed their work after a review by Alan McCully, who used to work as a Senior Lecturer in Education in the School of Education in Ulster University and well known for his work on history teaching in post-conflict societies.
- Monument(al) Challenges is a project which aims to address teachers' requirements for resources and training materials which equip them with the skills for discussing sensitive and complex histories, including colonialism and slavery, in their classrooms. The consortium is currently conducting research, and will develop a set of educational resources (an educational toolkit and various teaching-learning materials consisting of lesson plans, learning strategies, learning activities, and source collections related to contested cultural heritage). These resources will be piloted in school classroom settings and teacher training workshops. They will be disseminated to a wider audience through further workshops, a webinar series, and an accredited and self-paced online course.

- Seeking Justice is an Erasmus+ funded project uniting teachers and students across Europe to explore the meaning of international justice and the role of the ICC. It focuses on critical thinking about historical and current international crimes, encouraging an understanding of the roles of NGOs in achieving justice. The initiative culminates in an educational Toolkit based on the Rome Statute, emphasising citizenship, human rights education, and genocide prevention.
- **SENSEI** (School EducatioN for Sustainable and Equal Inclusion) is a project funded under the Erasmus+ program, designed to develop a module for Initial Teacher Training and a hybrid/blended International Continued Professional Development course. It aims to equip in-service and pre-service teachers with skills to create more inclusive and engaging (history) classrooms for all students. The project's objectives also include building a supportive network of teachers, producing tailored training programs with innovative teaching methods, and upscaling effective educational approaches.
- Watching Videos Like a Historian is a project supported by the European Union, as part of the Erasmus + programme. This project focuses on the use of Audio-visual (AV) material in the (history) classroom as a tool to promote historical understanding and to help students develop media literacy competences, especially in the realms of (1) searching and finding information; (2) evaluating and understanding information; (3) developing and presenting information. The project will result in supporting material for cultural heritage institutes that wish to increase the use of their AV collections in the classroom, as well as a toolkit for educators containing teaching strategies and exemplary materials on how to do so.

• Who were the Victims of the National Socialists?

EuroClio completed *Who Were the Victims of the National Socialists?*, a project in partnership with the Max Mannheimer Study Centre based in Dachau, Germany and funded by the Foundation Remembrance, Responsibility and Future (EVZ). The project resulted in five place-based learning local history projects in Belgium, Bosnia and Herzegovina, Denmark, Slovakia and Spain about the victims of Nazi persecution. Their experiences are captured in the Toolkit: *Who Were the Victims of the National Socialists? A Toolkit for Place-based Learning.* It includes a step-by-step guide for teachers and students on how to set up a local history project as well as historical content information sheets about different groups of people that were persecuted by the Nazi's. The Toolkit is available in Basque, Danish, Dutch, English, Serbian, Slovak and Spanish. Apart from the Team Members and the video producer, six project advisors, six council members and 23 external reviewers have been part of the project in different capacities.

Long term initiatives

- Rewind Network. EuroClio is pro-actively working with like minded organisations from
 around the world to achieve its mission. The idea is not only to learn from each other, but
 increase our impact through cooperation. To achieve this, we are facilitating online
 exchanges with leaders from other organisations. In 2023, we gathered the network in
 Vilnius during our Annual Conference and were invited to share our experiences during the
 Educating for Global Democracy Convening, hosted by the History Co:Lab, World Savy and
 the American Academy of Arts and Sciences.
- Contested Histories is ongoing research on divisive histories in public spaces led by the Institute of Historical Justice and Reconciliation (IHJR), which is based at EuroClio. By the end of 2023, the number of identified cases increased from 523 cases to 545 and from 123 different countries to 130. Initial research is done by under- and post-graduate students at Harvard University, the University of Oxford, Maastricht University and Erasmus University Rotterdam and Independent Researchers. In 2023, we published 26 cases on the website, and 1 occasional paper. This year the Initiative focused on developing more the already listed cases than adding new ones.
- Seeking Justice: From Nuremberg to the Hague" is a program especially directed to youth between the ages of 16 and 22, designed around the question: How to best serve justice when crimes are committed by those in power and national justice systems do not deliver? In 2023, we organised one such session for youth in The Hague. As a corollary to the youth program, we also realised two 2-day teacher workshops that prepared educators to incorporate these issues in their teaching programs and syllabi. The programme includes active methods such as research, discussion, group work, presentations, debates, simulations, onsite learning, and interactions with experts and eyewitnesses or victims. It culminates with visiting the International Criminal Court (ICC) and attending a current international criminal trial. The participants are challenged to identify examples of past injustices and critically assess how these were dealt or not dealt with. Before witnessing a real trial, the participants maximise their understanding of what will happen through research on the current case and an ICC-led session on how the court functions. The aim is that the participants leave the workshop experience with a better grasp of these complex issues and a more nuanced understanding of what justice and injustice are.

- **Historiana** is an online resource developed by and for history and citizenship educators in Europe and beyond. Historiana offers free ready-to-use learning activities, multiperspective historical content and digital tools. Each year we add new content and improve the functionality of Historiana. In 2023, the historical content team started to develop a global history of migration. The teaching and learning team has worked on the development of new resources, related to "Change and Continuity" and "Encouraging Multiperspectivity". The concept design and development team worked on better support for Audiovisual Sources on Historiana.
- In Europe Schools is an online school matching and documentary-making project for schools throughout Europe on modern European History, primarily focusing on four main themes: Difficult History, Migration, Climate Change and Gender Equality. EuroClio revived its partnership with the VPRO and agreed to develop at least three new Education Kits on the following topics: Fake News and Disinformation, the Fragility of Democracy, Social and Economic Inequality. The topic of the fourth Education Kit will focus on social and economic inequalities in Europe. The first new Education Kit on Fake News and Disinformation is now available. The Education Kits on Fragility of Democracy and A New Europe United in Diversity? Have been developed and will be launched soon.

The partner projects:

- Contested Histories Onsite, in partnership with the Memory Studies Association and EuroClio, are working together to publish a toolkit for educators and other stakeholders to better understand and address complex legacies of Europe's totalitarian past. This project shows guided tours of controversial monuments and aims to guide teachers in how they can approach these complex legacies onsite, as opposed to only in the classroom. In 2023, we finalised the toolkit which was translated into Spanish, Italian, Polish, Russian and Estonian, and recorded 3 video tutorials in the Valley of the Fallen (Spain), Forli (Italy) and Oxford (UK) as examples on how to give tours at contested sites. The results of the project were presented at the Memory Studies Association Conference in Newcastle (UK) in July 2023.
- The Europeana Foundation and EuroClio are working together to stimulate the use of digital heritage in education. This cooperation focused on the better integration of Europeana in Historiana, especially on the promotion of re-use of content present on Europeana. In 2023, we have held co-creation meetings between personnel of cultural heritage institutes and history and citizenship educators, which resulted in the development of new content for existing Historiana partner pages. In addition, we have done a translation campaign aiming at the translation of existing content on Historiana to other European languages, based on teachers' need.

- Critical History (led by Tallinn University), a project funded through the Erasmus+ programme of the EU and consisting of a consortium of four European universities in addition to EuroClio, ended in September 2023. The project led to the publication of a study guide, with learning activities and teaching methods and tools on four topics: Heritage in history education, global dimensions of national history and post-colonial history, public history and history education, and the role and influence of the internet in history education. EuroClio led the efforts to collect teaching practices on these topics and took over from Salamanca University the task of authoring the chapter on internet in history education. The Study Guide was presented at the Annual Conference of the International Society for History Didactics in Tallinn in August 2023 and has been published in Estonian, German, Spanish and Polish translations.
- Histories that Connect Sri Lanka is a partnership between EuroClio, the Collective for Historical Memory and Dialogue (CHDM, in Colombo) and the 'Strengthening Social Cohesion and Peace in Sri Lanka' (SCOPE) initiative of the German Development Agency, GIZ. It continues the work of a pilot initiative that ended in 2022. The main project aim is to foster a network of history teachers and historians working across ethno-linguistic divides in Sri Lanka. In 2023, the project organised two seminars for history teachers focused on historical thinking concepts in Kandy and in Jaffna with a webinar and other project work aiming to develop educational materials taking place online.
- Football Makes History II (led by Erasmus University Rotterdam) is a Strategic Partnership in School Education that continues the efforts of the Football Makes History project, which ended in 2021. This project will facilitate the work of schools, museums and (local) football clubs in using sports heritage for educational purposes. To that effect, EuroClio has recruited a team of educators producing a toolkit providing teachers with a step-by-step guide on how they can build effective local partnerships with football clubs, football club museums and/or other sport organisations. In addition, the project will develop a documentary, a student video competition, and launch an extensive outreach campaign on the potential of sports and sport heritage as an educational tool.
- Innovation Station EuroClio is working together with the Organising Bureau for European School Student Unions, the Hellenic Open University, EGinA, the Impossible Foundation to develop tools and collect best practices for teachers and students that will help them navigate online and blended learning environments. In 2023, EuroClio organised a staff training workshop in Italy, where Ute Ackermann Boeros and Stefania Gargioni facilitated two sessions, zooming in on specific aspects of online and blended learning. In September 2023, EuroClio also published the Guidelines for Teachers on Online and Blended Learning, co-authored by Ute Ackermann Boeros, Igor Radulovic and Katarzyna Pelc.

- Changing Democracies EuroClio is working together with the Evens Foundation and eight other partners across Europe on capturing stories of democratic transition to challenge young people and the wider audience to critically reflect on our democracies nowadays. In 2023, 30 testimonies across Europe have been recorded and will be used as a starting point for the educational resources and the online engagement activities for which EuroClio is responsible. EuroClio is also closely working together with its Dutch partner, Autres Directions, on facilitating a local experience. The project is funded through the European Union Remembrance grant scheme (part of CERV).
- Making Visegrad Histories Digital- EuroClio is working together with Center for Education and Innovation (SK), Hungarian Historical Society (HU), German School of Prague (CZ) and Wroclaw University (PL) to create tools for teaching the history of state socialism in the four Visegrad countries. As a first part of the project, EuroClio organised the "Budapest Academy" (17- 19 November 2023, Budapest). It was a teacher training event where the authors and reviewers of the project (coming from Hungary, Poland, Czechia, Slovakia, Italy, Georgia, The Netherlands, Bosnia) were grouped into teams and met the historians and project advisors with whom they will cooperate. In the following months, the authors will start working on the teaching tools, with the guidance of the historians and project advisors.

The partnerships:

- The Council of Europe has continued the work of the intergovernmental project "Educating for diversity and democracy: teaching history in contemporary Europe" and established "The Observatory on History Teaching in Europe" through an enlarged partial agreement. Since 2021, EuroClio has been represented in the Experts Working Group on History Education, which is supporting the intergovernmental project. The intergovernmental project organises an annual Forum on history teaching, with EuroClio represented in the organising committee for 2023 ("History Education in the Digital Age", Brussels, March 2023). In 2023, EuroClio was also contracted to work with the CoE Roma and Travellers Team on producing educational material on Roma and Traveller history (to be completed in 2024). EuroClio was selected as the only consortium in the expert's group working on the first regular report of the Observatory. This report will be published every three years and give insights into the state of history education in the states who are participating in the Observatory. A draft of the first Report is available on the Observatory webpages.
- The House of European History. In the past few years, EuroClio has been engaged in a fruitful partnership with the House of European History, especially in relation to the cohosting of training and peer-review of educational material. In May 2023, EuroClio and the House of European History co-hosted a communications training for our member associations, resulting in several reviews of the Museum published through our members' bulletins. The House of European History has made a proposal to co-host the 2026 EuroClio Annual Conference in Brussels.

- The International Baccalaureate. The International Baccalaureate. In late 2021, EuroClio and the International Baccalaureate (IB) started developing an action plan for the creation of video training material on "Decolonising the Curriculum". EuroClio hosted focus groups with IB teachers to learn more about their needs in terms of training and supporting materials. The focus groups resulted in the development of three lectures on how to use inclusive language, the use of oral histories in the classroom, and the use of textbooks.
- The United Nations International Residual Mechanism for Criminal Tribunals (MICT) has renewed its partnership with EuroClio to reach history teachers across the former Yugoslavia. This collaboration is part of the outreach efforts of the former UN tribunal for Yugoslavia (ICTY) with the aim to facilitate the use of the ICTYs archives among local history teachers. Adapting to the pandemic, parts of the programme of teacher training workshops have been moved online or to hybrid formats. The partnership has been expanded to include Croatia along with BiH, Serbia, Montenegro, North Macedonia and Kosovo. The project continued in 2023 with the publication of a handbook for educators on how to include the archives of the ICTY in their teaching.

4. Key Activities

Research

EuroClio has continued its research for the Contested Histories cases and has grown its database and mapping study to 545 case studies by the end of 2023, of which 90 were published after peer and external review. The research is now available on contested histories.org.

We also worked with Bjorn Wansink, Associated Professor at Utrecht University, to research how the war has impacted history teaching in Ukraine. For this, EuroClio facilitated the recording and transcription of 16 interviews. These will be analysed and used for an article.

EuroClio coordinated the work of the Experts Team working on conducting qualitative and quantitative research for the General Report on the State of History Teaching in Europe of the Council of Europe's Observatory of History Teaching in Europe. In 2023, we disseminated the questionnaires aimed at teacher and educational authorities, and conducted 11 focus groups with history educators, teacher trainers and curricula developers. By the end of the year, the final draft of the Report was submitted and is now available at the Observatory's website.

In 2023, EuroClio hosted research trainees from Maastricht University, Central European University, Oxford University, Harvard University, and Erasmus University Rotterdam and established a new partnership with Aarhus University to have trainees on the Autumn Semester working at the EuroClio Secretariat.

Advocacy

EuroClio continued its work with the Council of Europe (CoE), it was represented in the Expert Working Group on History Education, contributed to the Parliamentary Assembly of the Council of Europe (PACE), coordinated the experts group researching the Regular Report of the Observatory of History Teaching in Europe, and led the focus group component.

For our work with the Council of Europe, EuroClio took part in the organising committee of the 2nd Annual Forum on History Teaching ("History Education in the Digital Age", Brussels, March 2023). In 2023, EuroClio was also contracted to work with the CoE Roma and Travellers Team on producing educational material, as well as policy documents - including recommendations for curriculum developers - on Roma and Traveller history (to be completed in 2024). EuroClio also actively participated in the European Innovation Days for History Teaching (Brussels, March 2023), a joint effort by the EU and the CoE. Finally, EuroClio was selected as the only consortium in the expert's group working on the first regular report of the CoE Observatory on History Teaching in Europe. EuroClio advocated on behalf of OHTE and made use of its network in gaining sufficient responses to the teachers' questionnaire for the regular report. A draft of the first Report was published in December 2023.

We worked together with UNESCO for recording teacher testimonies on how they have dealt with instances of antisemitism in the history classroom and they would respond to a set of different scenarios. The recordings were made at the EuroClio Annual Conference in Vilnius and question prompts were developed by Dr. Arthur Chapman from University College London.

EuroClio worked on the creation of the 52 minute documentary "War on Education" with Stefano di Pietro, who directed the film, the History Co:Lab, who co-produced the film, and colleagues from Ukraine. The documentary with the Ministry of Education of Ukraine, UNICEF Ukraine, and other significant actors in the field of Ukrainian education, including teachers, students, historians, NGOs and journalists. The documentary will be released on February 24, 2024, marking a 2-year commemoration of Russian full-scale invasion of Ukraine, launching a global campaign.

Fundraising

In 2023, EuroClio submitted 7 project applications of which 4 were successful (Facts not Fiction, Seeking Justice, History Education Beyond Borders III and SENSEI). EuroClio also joined 7 partner applications of which 2 were successful (Making Visegrad History Digital, with CEDIN and Changing Democracies, led by the Evens Foundation).

We agreed on a work programme for the second year with the Europeana Foundation within the European Data Space for Cultural Heritage. We successfully applied for the 3rd year of funding in the 2022-2025 framework partnership agreement with the European Commission for the Citizens, Equality, Rights and Values (CERV) Programme, European Remembrance Strand.

Most of these projects are connected to long term initiatives, meaning that the results of past work will continue to be expanded upon, ensuring sustainability. The Evens Foundation extended the partnership with EuroClio and agreed to co-fund a regranting scheme for EuroClio Members, which is part of the Operating Grant.

In 2023 Euroclio also focused on the fundraising for the creation and printing of the educational material for Ukrainian students. As a result, Klett Publishing House supported the initiative and made a private donation for the production of the featured documentary War on Education and the printing of the textbook "History of Ukraine and the world" for grade 6. Together with the support of EuroClio and Klett Publishing House the Svitych Publishing House, Ltd. successfully printed and distributed the textbook to the schools in Ukraine. Other sponsors have joined the initiative and supported the creation of the featured documentary.

Educational Resources

In 2023, we worked on the development of a range of educational resources. The following resources were published:

- Teachers Guide for Effective Online Teaching (as part of the Online Teaching in the Visegrad Region)
- A toolkit on Fake News and Disinformation (written by Harri Beobide for the In Europe Schools initiative).
- A toolkit for place-based learning on the question "Who were the victims of the National Socialists?"
- Innovation Station Guidelines for Teachers.
- Contested Histories Onsite Toolkit "How to give a tour around contested sites?", translated into Spanish, Italian, Estonian, Russian and Polish. The toolkit aims to offer educators and other stakeholders tools on how to better understand and address the complex legacies of Europe's totalitarian past by providing critical history tours.
- The Critical History Study Guide, aimed at students at teacher trainer colleges as well as in practice teachers, with several examples of teaching practices
- The Art of Questioning, a resource on Historiana, designed for teachers, to support them to engage all learners, deepen thinking using questions, and develop their learner's ability to ask their own questions.

Professional Development

In 2023, EuroClio continued hosting online events, pairing them with in-person training. In response to changing demands, habits and preferences of teachers, and to build a repository of resources that we can use for the future, we are also creating quality live recordings of the face to face meetings, that we can use for online learning that teachers can do at their own pace, at a moment that is convenient for them.

The online presence of EuroClio focused on four major topics, which were explored in dedicated webinar series aimed at training participants not only on how to approach the topics at hand in a meaningful and engaging manner but also on how to innovate their online teaching practice. Each webinar series took place over the span of three months and was complemented by an ambitious outreach campaign.

The themes tackled in 2023 were:

- From January through March: The use of Video Testimonies in the classroom;
- From April through June: The use of Video Testimonies in the classroom; The experience of Women and Children during wartime; The Troubles and the Good Friday Agreement
- From July through September: Historical fiction in the classroom; Pre-colonial civilisations and peoples of Latin America;
- From October through December: Teaching history at a time of planetary crisis; Wearing Cultures: How to teach history with fashion; Voices of the "New World": Testimonies and commentaries of the Latin American conquest; Independence and Decolonisation in Latin America: The case of Paraguay, 1800-1870; Wearing cultures: How to teach history with fashion; Old World, New World: Postcolonial Politics, Production, and Innovation

In total, EuroClio trained more than 75 educators over more than 30 online sessions throughout 2023.

In addition to this, in 2023 we have hosted the following in-person trainings:

- The 29th EuroClio Annual Conference, themed "The Complexity of History: Unpacking the Past," took place in Vilnius, Lithuania, between 20 and 22 April. The conference was organised in partnership with Lithuania History Teachers' Association, University of Vilnius, GoVilnius, Palace of the Grand Dukes of Lithuania and saw 135 participants from 30 countries: Serbia, Croatia, Poland, Lithuania, The Netherlands, Portugal, Spain, Romania, Bulgaria, Austria, Belgium, Bosnia, Denmark, Slovakia, Czechia, Greece, Malta, Iceland, Luxembourg, Cyprus, Italy, Estonia, Germany, USA, Finland, Hungary, Canada, Ireland, Latvia, Japan.
- The Thematic Seminar on "Teaching Jewish Heritage in your class. Using Jewish cemeteries in education" took place in Bratislava (Slovakia) on 30 and 31 October 2022. It was co-organised by Euroclio, Centropa, and the Foundation for Jewish Heritage, and there were 39 participants and 5 speakers from 13 different countries.
- The Seeking Justice: From Nuremberg to The Hague seminars welcomed 45 teachers and 13 students, across several events in The Hague
- As part of the Parallel Angles: Making Visegrad History Digital project, the Budapest Academy welcomed
- On 13-14 May 2023, we partnered with the House of European History in Brussels to
 organise a seminar for the editors of our members association's bulletins and newsletters.
 The seminar, titled 'Writing History: Communication Training for History Teachers
 Associations' brought together 15 participants and featured workshops by EuroClio staff, a
 history professor based in the UK and the staff at the House of European History.

 Over two events in Kandy and Jaffna, EuroClio welcomed a total of 50 Sri Lankan history educators for seminars on historical thinking concepts

Furthermore, EuroClio was involved in the creation and pilot of the online self-paced course titled "Creating High Quality eLearning Activities" which took place from 27 February to 31 May 2023. This course was held in the framework of the European Data Space for Cultural Heritage" and involved 27 participants from across the world.

EuroClio also contributed to a number of training events as a partner or invited workshop hosts, including but not limited to the European Innovation Days in History Education (CoE, Brussels, March 2023), the 2nd Annual Forum on History Education (CoE, Brussels, March 2023),

Finally, EuroClio trained over 8 full-time trainees and over 38 research trainees and volunteers. Moreover, the association has provided many opportunities for its staff to develop different skills over the years.

Outreach and Exchange

Throughout 2023, EuroClio shared information via its newsletter, its website, and via various social media platforms, among them Facebook, Twitter, LinkedIn and Instagram - with steady levels of growth in followers across these platforms. Work on the EuroClio podcast *Past Times: Talking and Teaching History* continued and the new studio has improved the audio quality of several of the 8 episodes published in 2023. The podcast content varies from AI/Chat GPT in the classroom to episodes focusing more on EuroClio projects and their outputs. In addition, the annual report of 2022 and two Bulletins were published, as well as numerous in-depth articles, reviews, blog posts and shorter news posts highlighting opportunities for our community.

The EuroClio Short Stories are a series of interviews conducted with experts from our network. In these short clips, we present a variety of perspectives on the importance of accurate history education and how it fundamentally shapes the world we live in today. The stories are produced by EuroClio, created by In Medias Res and directed by Stefano Di Pietro. In 2023, we produced six such stories.

In 2023, EuroClio recorded five 'Conversations' as a pilot. In the conversations, two members of our community and experts in their field discuss a topic of their choice that is relevant to the wider community of practitioners. Topics have included Eurocentricism, Emotion and Diverse Education. These conversations will be published in the coming year.

5. Financial result and policies

During 2023, EuroClio continued to work on its mission through projects and activities, supported by a range of donors. The main source of income (51 %) were projects, followed by Core Funding (44 %), Consultancies (3 %), professional development fees (1%) and membership fees (1%). The main sources of expenditures were staff costs (30%), followed by direct project expenditures (30%), other expenditures (25%), Regranting (6%) and depreciation (2%).

Operating grants

EuroClio received core funding from the European Union Europe for Citizens Programme and from the Open Society Foundation's Education Support Programme. This core funding supports the main activities and covers the core costs of EuroClio.

2023 was the 2nd year of the Framework Partnership Agreement between the European Union and EuroClio 2022-2025. This operating grant, managed at the European Commission 'Europe for Citizens: European Remembrance' programme, supports the activities of EuroClio that are related to Remembrance.

Regranting

The regranting scheme, made possible by the EU Operating grants, which was co-financed by Evens Foundation, gave EuroClio the possibility to provide grants to its member associations for the first time.

The Regranting scheme aimed to increase transnational cooperation amongst history educators, develop a strong civil society within EuroClio's member associations, broaden EuroClio's reach, and increase EU awareness of its values, history, and cultural heritage.

In order to achieve these objectives, the Regranting scheme was split into two categories of events: the first involved a winning member association organising a Pan-European Gathering with 52.000 euros available, and the second was referred to as Regional Cooperation and involved 6 events organised by 6 winning member associations with 6.000 euros each available. EuroClio, together with Evens Foundation selected all the grant winners.

Clio '92, the Association of Research Groups on History Teaching and Learning, was awarded grants for the Pan-European Gathering. The organisation convened a three-day event in Bergamo and Brescia, bringing together over forty history teachers to explore three crucial issues related to teaching history: environmental sustainability, migration, and inclusivity. The final product will be an online open-source volume that presents our viewpoint on the subjects to academics, teachers, and national and European institutions.

In the second type of regranting, known as Regional Cooperation, members of EuroClio worked to enhance or expand the transnational component of their capacity-building initiatives, with events

such as seminars, workshops, or summer schools. The following were the six selected member associations and related event:

- Estonian History Teachers' Association (EAUS) with an Annual Summer School that took place in Pärnumaa
- Croatian History Teachers Association (HUNP) with a Forum on History and Remembrance Education in the Post-Yugoslav space, held in Pula Croatia
- Society for Historical Sciences Romania with a Teacher Training Event on European Remembrance held in Bucharest
- Association for History Education in Greece (AHEG) with a workshop Approaching the Migration Experience: Albanians in Greece (1990-2023) in Athens and Tirana
- Slovenian History Teachers' Association with a Teacher Training on teaching about WWII in Liubliana
- Association for Historical Dialogue and Research (AHDR) with an online exchange event and exchange of resources between Cypriot and Georgian history educators.

Financial and partnership support

Financial Result

In 2023, EuroClio closed the year with a positive result of € 205, which has been attributed to the operating reserve. The income generated through projects, core funding, membership fees and consultancy has been approximately the same that was spent.

Throughout the year EuroClio has been monitoring and reducing costs to achieve this result. Good oversight for the Association, alongside the normal external accountancy/audit scrutiny, was ensured by the Board's Financial Committee, and regular Board to monitor the financial health of EuroClio, and take measures where needed. EuroClio has monitored the expected vs realised income and expenditures regularly and kept an updated overview of the liquidity planning.

Contingencies

The 12.000 euro budgeted for contingencies has not been used. There has been unforeseen income. This is due to the changed VAT position of EuroClio. There is 39.689 euro VAT paid for activities that are subject to VAT, including seminars organised in the Netherlands and video production.

Operating Reserve

It is the policy of the Board to allocate positive results to an operational reserve. Such an operational reserve is needed to secure the continuity of the organisation but also to avoid issues related to liquidity and to improve the financial operational capacity of EuroClio.

The board steers towards an operating reserve that is the equivalent of one year core costs, which is currently estimated at 300.000 euro, but to build this at a pace that does not stand in the way of EuroClio from maximising its impact in the present.

At the closing of the 2023 accounts, this reserve now stands at € 112.225 (compared to € 112.020 at the end of 2022)

Over time

In 2023, the EuroClio staff members worked more than they were contractually obliged. A reservation for up to 15 in lieu days is included in the accounts to compensate for the overtime for staff members who want to make use of this. The rest of the overtime, which is the equivalent of € 33.725 (compared to € 41.704 in 2022), has been waived by those staff members to which this applied.

7. Plans and challenges for 2024 and beyond

In 2020-2024, the Association wants to further develop EuroClio as a professional community of history and citizenship educators. For this, more educators need to be reached and ensure that they benefit from the work done by the Association and are being mobilised. To achieve this, we will focus more on core activities and long term initiatives and less on (partner) projects, work on strategic partnerships and increase our support to professional volunteers.

We will work on

Research, by identifying relevant practices and resources on the focus areas and thematic
priorities we work on, using and refining a measuring system to monitor and evaluate the
impact and progress of our work, writing articles on the history of EuroClio, and mapping
the needs of history and citizenship educators.

Starting in 2024, we have recruited a group of six Research Fellows. They are independent researchers and PhD students from different disciplines working in the field of history education. The aim is that the research fellows will significantly contribute to our research output, making sure that our overall work, projects and advocacy efforts match the actual needs of European history educators.

In addition, we will continue to support the research done for the Council of Europe Observatory of History Teaching in Europe, do qualitative research on the impact of projects and long term initiatives, and research into the needs and experiences of educators. In 2023, we started a pilot with the recording of teacher testimonies on the most formative moments in their career.

In 2024, we will continue to build partnerships with research organisations, including Erasmus University Rotterdam, Harvard University, Maastricht University, Utrecht University, and Oxford University.

Advocacy, by consulting our members on key issues, representing their interests and
voicing their concerns by working with intergovernmental organisations (including the
Council of Europe, the European Parliament, the OSCE and the United Nations), by
updating the EuroClio Manifesto, issuing and responding to policy recommendations, and
mapping quality standards for history and citizenship education.

In terms of cooperation with international organisations, we will participate in the working group on history teaching at the Council of Europe, continue our work as core partner in the HISTOLAB project of the Observatory of History Teaching in Europe and the European Commission. For the policy recommendations, we will use the findings from the research we do on the focus groups.

In addition, we plan to support policy reform in those countries who want to steer their educational system towards the principles outlined in our manifesto and are interested in cooperation.

Fundraising. For this, we will prioritise fundraising for our long term initiatives, for projects
and activities that make use of projects that were successfully completed, arrange
meetings with representatives of previous, current and potential donors, and refine the
workflow for identifying, documenting and responding to leads for fundraising.

A priority is acquiring fundings that is not from the EU. We will continue our War on Education campaign to support the transition of history and citizenship education in Ukraine in line with the "New Ukrainian School" reform that started in 2018. We will seek support to foster a learning network with like minded organisations who are also working towards the same or similar goals in the field of education in other parts of the world through the Rewind Network. For private fundraising, we will align ourselves and seek support from the Friends of EuroClio Foundation.

Professional development, by offering several series of online opportunities for
professional development on thematic priorities, map workshops that we can embed in
events organised by members and partners, work on capacity building through our
projects and partnerships, offer (research) traineeships to university students and young
professionals, and enable our staff members to develop professionally in their area of
work.

To increase the impact of the face to face events that we organised, parts will be live recorded and edited, so that people who were not at the event can benefit from them and we can use the recordings in future activities and resources. In terms of online learning we will move from offering mainly webinars to the creation of online courses that participants can follow at their own pace.

As a deliberately developmental organisation, we believe that educating ourselves will be beneficial for the organisation and the level of achievement of our mission as well. Therefore we put emphasis on the professional development of the staff. There will be joint workshops on effective communication and teamwork, but also opportunities for individual staff members to meet their own professional development needs.

In terms of partnerships, we aim to work more closely with institutes who are responsible for educating future teachers. In addition, we will try to facilitate peer-learning, because we know that learners, including teachers, researchers and professors, are more willing to learn from others who have similar experiences and needs. This peer learning also helps to strengthen networks and the EuroClio community.

Educational resources. The development of educational resources by EuroClio is always
done as a collaborative process including design, including testing, peer-review, editing in
transnational teams. Since we have a wealth of materials and resources already available,
we will focus more efforts on curation, translation and adaptation of existing resources
instead of creating new ones. Finally, we will work more with museums, archives, libraries
and memory sites as places for learning.

The resources that we do develop will be designed in such a way that they are adaptable and can be remixed. For this we will use open licences and open formats. They include lesson plans, source collections, animations, eLearning Activities and digital tools. We will create these as part of projects, flagship initiatives, strategic partnerships, and map relevant resources related to our priority themes, thereby responding to the current needs and developments of history and citizenship educators internationally.

Other resources that we will continue to develop are guides that help teachers and learners address shared challenges, toolkits that can be applied in different contexts, learning activities that are adaptable, and teaching strategies that can be localised. In these we will integrate testimonies and video tutorials that we can record in our (travelling) studio.

 Outreach and exchange, by developing and sharing inspiring and useful content (in the form of blogs, reviews, digests, podcasts, videos) through our website, newsletter, social media, and bulletin, by developing PR materials to support advocacy, fundraising and member recruitment (including a video introducing EuroClio and its work), and by continuing to systematically map and use communication and dissemination channels.

To reach a bigger audience and introduce EuroClio to people who are yet familiar with us, we will produce short stories and animations. We will also create other formats, such as the Past Times - Talking and Teaching History podcast, and recorded conversations, to share insights and practices, shift mindsets and spark discussion within our community. In terms of learning, we are researching how to find out how to make better use of social media.

For our long term initiatives, we will:

 Further develop Historiana as a tool for educators to find and create resources for innovative and responsible history and citizenship education. We will focus on making existing content easier to find (through browsing, filtering, tagging and sorting), enabling partner organisations to contribute to the development of Historiana, and making it easier to create content.

A priority is the recruitment of new team members for the historical content and the teaching and learning teams. Ideas for the concepts, design and development will be based on research with representatives of user groups.

Research cases of Contested Histories available on contested histories.org, promote the
use of the existing research by educators and policymakers, and use it ourselves to raise
awareness of the importance of history and memory for intergroup relations. In addition,
we will continue the mapping study, research new cases and select cases that will be kept
up to date.

We will regularly publish new cases of contested histories, do and publish additional in depth research in the form of occasional papers. With a growing number of cases available, we encourage the researchers working on contested histories to compare and contrast case studies. The publication of guides to give tours at contested sites, research on the way contested histories are taught in practice, and the development of educational resources designed to teach and learn about contested histories, will further increase the relevance of this initiative in the field of education.

 Continue to promote and support teachers and students to work with the In Europe Schools toolkits. We will make and publish starter clips on new themes and create additional materials.

Themes and priorities

EuroClio will advance its work in the following focus areas that are part of the strategic plan 2020-2024.

- Promote a transnational and multi-perspective approach to history education.
- Make learning history motivating, meaningful and inclusive.
- Use new technologies to enhance history education.
- Prevent and resolve conflicts related to history and memory.
- Support educational reform based on democratic values.
- Use research to advance the teaching and learning of history.
- Advance teaching and learning about the European Union.

In addition, there are thematic priorities for each year, such as emotions in the classroom and the art of questioning. For each of these priorities, we will identify relevant practices and resources, offer opportunities for professional development and work on outreach and communication.

Membership recruitment and involvement

EuroClio will offer various ways in which members can engage with the work of EuroClio. Members have free and unlimited access to webinars and online events, can start and join special interest groups, get refunds for reviews of podcasts, books, games and exhibitions, can use the online conferencing software from EuroClio, and get advice on fundraising. EuroClio will offer more membership services as the membership grows.

Because not all EuroClio members were eligible for the regranting scheme, for the moment, we are not continuing the regranting scheme.

EuroClio members can continue to use the training catalogue which lists training sessions and workshops that have been successfully carried out in the past and could be offered again during events organised by its members.

Strategic partnerships

EuroClio will continue its work with strategic partners and alliance building. These partners include the Bundeszentrale für Politische Bildung (BPB), the Centre for Historical Culture (CHC), the Council of Europe (CoE), European Network of Remembrance and Solidarity (ENRS), European Schoolnet, the Evens Foundation, Europeana, European Observatory on Memories (EUROM), Facing History and Ourselves (FHAO), the Global Centre for Pluralism (GCP), the House of European History (HoEH), the Institute for Historical Justice and Reconciliation (IHJR), the International Baccalaureate (IB), the Leibniz Institute for Educational Media | Georg Eckert Institute (GEI), the Lifelong Learning Platform (LLLP), Memorial de la Shoah, the Network of Concerned Historians (NCH), the Organization for Security and Co-operation in Europe (OSCE), the UN International Residual Mechanism for Criminal Tribunals (UN MICT), UNESCO, the Northeast Asia History Foundation (NAHF), and a range of Universities and Teacher Training Institutes across Europe.

Predicted Challenges and Risk Mitigation

In terms of risk management, we identified several challenges that could affect our work in the EU operating grant. For 2024, these are

- Resurgence of global health crisis and travel restrictions;
- Hacking and ransomware;
- Bankruptcy or collapse of partner organisations;
- Long term sick leave;
- Liquidity;
- Compliance;
- Financial misconduct;
- Lack of data from stakeholders to effectively measure impact;
- Exclusion of minorities or lack of representation to our projects and activities;
- Politicised misrepresentation or wrongful framing of our work;
- Difficulty to reach high impacting people;
- Lack of cooperation, or explicit hostility, from government officials or bodies towards our work;
- Travel and visa restrictions for participants to events and projects, or teachers are not granted the time necessary to join events;
- The resources developed are not fully transferable to different contexts; and
- Inflation makes the activities more expensive than budgeted;
- Secondary discrimination.

For each risk, we have taken countermeasures. To assess if these are sufficient, we review these each quarter with the staff. In addition, we do a risk assessment and evaluation every year. The biggest risk that was identified in 2023 is burnout of the staff.

Human Resources

In 2023, the EuroClio staff has increased to more than 6 f.t.e. (full-time equivalent). This increase reflects the ambition of EuroClio to grow and increase its impact. More staff enables us to prioritise thematic work, offer more and better membership services, provide better support to the teams leading the long term initiatives, and manage more projects and partnerships.

Additional funding, greater diversity in donors

EuroClio will work to diversify its funding in order to increase its impact, to be better able to respond to opportunities and challenges related to our mission and to be more resilient to changes in the funding landscape so that we can continue to function on a professional level in the future as well.

In terms of priorities, we will seek financial support for current projects, long term initiatives, and projects that build on the results of successfully completed projects. For this, we will explore private fundraising and seek support from Ministries of Foreign Affairs and work towards acquiring the CBF quality label for charitable organisations in the Netherlands.

Operating Grants

2023 is the second year of the EU Europe for Citizens Operating Grant that EuroClio currently receives for its work on European Remembrance. This support will continue until the end of 2025. The Evens Foundation has provided support for the Annual Conference and the regranting scheme to members.

Covid-19

In 2023, we anticipate that the negative impact of Covid-19 on our work will further reduce. All face to face activities, including the Annual Conference, that were foreseen in 2022 took place. Therefore we will not have restrictive measures. We do however keep unforeseen costs in the budget of 2024.

Activities

EuroClio, the European Association of History Educators (Chamber of Commerce number 27263208) is statutory established at the Bankaplein 2, 2585 EV, The Hague, the Netherlands. EuroClio is a democratic Association that brings together other democratic associations at its General Assembly. This body adopts overall planning, elects and discharges board members and follows good governance procedures, which are governed by the EuroClio Statutes and Internal Rules.

The mission of EuroClio is to inspire and empower educators to engage learners in innovative and responsible history and citizenship education. The vision of EuroClio is for all learners to become more responsible and contributing citizens through engaging in history and citizenship education for mutual understanding and peace.

EuroClio's is working to advance its mission by:

- Applying for and implementing projects with and for history and citizenship educators and their associations. EuroClio can also join projects led by partner or member organisations.
- The collaborative design, review and publication of open educational resources that are ready to use, and free to share and adapt by educators and learners. The development process is part of capacity building and includes measures to control the quality, such as peer-review, external reviews, and piloting. EuroClio develops resources that can be used online of offline. The resources are based on active methods and promote historical and critical thinking through a multiperspective and inclusive approach to teaching and learning history and citizenship.
- Offering online, offline, and blended opportunities for professional development of history and citizenship educators. The professional development offer includes activities such as: Conferences, Seminars, Workshops, Lectures, Roundtables, Webinars and Online Courses. Most of these activities are centred around a theme that is relevant for EuroClio's mission.
- Sharing information that helps to advance the teaching and learning of history education. This is done by writing and sharing articles, opportunities, reviews of books, games, and podcasts, making and publishing our own podcast and bulletin, maintaining, and updating our website, sending direct mailings to members, sharing information via social media, and issuing press releases.
- Advocating for innovative and responsible history education, especially on international level. For this, EuroClio makes policy recommendations, responds to consultations, and represents its community during experts meetings organised by intergovernmental bodies who are working on education, such as tthe European Commission, the Council of Europe, the Observatory of History Teaching in Europe, the OSCE and UNESCO.
- Researching and documenting insightful practices, resources that are relevant for its annual thematic priorities, the needs of history and citizenship educators and their students in particular country contexts and cases of contested histories.
- Sharing expertise through consultancies, for example by reviewing and advising on curricula, the design of professional development courses, and by giving workshops or lectures on demand.

More information about EuroClio's activities can be found in the Board Report and euroclio.eu.

Continuity

It is the policy of the Board to allocate positive results to an operational reserve. Such an operational reserve is needed to secure the continuity of the organisation but also to avoid issues related to liquidity and to improve the financial operational capacity of EuroClio.

The board steers towards an operating reserve that is the equivalent of one-year core costs, which is currently estimated at € 300.000, but to build this at a pace that does not stand in the way of EuroClio from maximising its impact in the present.

At the closing of the 2023 accounts, this reserve now stands at € 112.225 (compared to € 112.020 at the end of 2022)

A priority is the acquisition of funds that are either unearmarked or support the development of long-term initiatives. Since 2006, EuroClio receives an Operating Grant from the European Union, in the form of Annual Operation Grants.

In 2021, EuroClio was able to secure operational and core support from the European Union for the period 2022 – 2025 as part of the Citizens, Equality, Rights and Values (CERV) Programme, for the four years to support the growth of the association. The funding through this grant will remain stable at € 550.000 in 2024, which is a significant increase compared to € 300.000 in 2022.

In 2024, EuroClio will strive to secure operational and core support from new foundations and organisations.

General accounting principles for the preparation of the financial statements

General

The annual accounts are prepared on 10 October 2024 in accordance with the Dutch accounting standards for small and not for profit organizations (RJ C1).

Valuation of assets and liabilities and determination of the result takes place under the historical cost convention. Unless presented otherwise, the relevant principle for the specific balance sheet item, assets and liabilities are presented at face value.

Income and expenses are accounted for on accrual basis. Profit is only included when realized on balance sheet date. Losses originating before the end of the financial year are taken into account if they have become known before preparation of the financial statements.

Foreign currency

The annual accounts are presented in Euro's.

Assets and liabilities in foreign currencies are translated at the year end rate of exchange. Transactions in foreign currencies are translated at the actual rate of exchange. The resulting exchange differences are accounted for in the profit and loss account.

Reimbursements are issued in euro's using InforEuro exchange rates.

Accounting principles for the valuation of assets and liabilities

Tangible fixed assets

Tangible fixed assets are presented at cost less accumulated depreciation and, if applicable, less impairments in value. Depreciation is based on the estimated useful life and calculated as a fixed percentage of cost, taking into account any residual value.

Project receivables and project liabilities

Projects are valuated at realized expenditures covered by the grant less received instalments.

Receivables

Receivables are included at face value, less any provision for doubtful accounts. These provisions are determined by individual assessment of the receivables.

Cash

Cash consists of cash and bank accounts and are at the Associations free disposal.

Pensions

The pension scheme is in fact to classify as a defined benefit scheme. The pension scheme is regulated by ABP. EuroClio uses the exemption mentioned in the Dutch accounting standards to work out this scheme as a defined contribution scheme. Therefore it is sufficient to include the pension premiums to be paid in the profit and loss account. As a result of this, there are no negative or positive risks committed with this pension scheme taken in the valuation of the liability.

Accounting principles for the determination the balance income and expenditure

Revenues from services are recognised in proportion to the services rendered. The cost price of these services is allocated to the same period.

Operating grants

Operating grants are included in the profit and loss account in the year to which the subsidized expenses are charged, if the assumption is that the subsidy conditions will be met.

Long-term obligations

Long-term obligations have been entered into for the rental of the office in The Hague. This agreement includes office rental and service costs. The rental agreements amount to € 60.670 for 2024. The contract can be ended with a 2-months' notice.

EuroClio has partnered with the Centre for Historical Culture at the Erasmus University Rotterdam to reduce the gap between research and practice on history teaching. EuroClio is covering the cost to replace the Executive Director using the standards of the NWO (the Dutch Research Council). The costs are estimated at € 18.060.

EuroClio has a memorandum of understanding with the Global Impact Institute to build EuroClio's capacity to measure, showcase and increase its efficacy and impact for the period 2020 − 2025. The costs for this are € 5.000 per year.

Appropriation of operating result

The total income exceeded the total expenditures by € 205. The result of € 205 has been added to the Association's operating reserve.

Funding conditions

EuroClio implements its activities within approved plans, which are subject to various types of funding. Every funding obtained by EuroClio under such contracts is subject to the full delivery of approved activities, and compliance with standard administration procedures, initial eligibility criteria and reportage commitments.

There are specific conditions which EuroClio must comply with, which are different for different types of grants. These are addressed below, where significant:

The EU European Remembrance Operating Grant 2023 is part of the Citizens, Equality, Rights and Values Programme (CERV) Framework Partnership between EuroClio and the European Education and Culture Executive Agency (EACEA) which covers 2023-2025. There is a co-financing condition of 20% to be eligible for the maximum funding of 550.000 for 2023. The additional funding cannot be resourced from other EU grant, but can come from other sources, such as membership fees, financial support from third parties. Professional volunteering is also recognized as co-financing.

In 2023, EuroClio was leading three projects funded by the EU Erasmus+ programme and was a partner in three projects under the same funding scheme. As project partner, EuroClio provides the project coordinator with insights on its financial capacity periodically, mostly through signed timesheets and financial reporting. As a project leader, EuroClio reports continuously in the EU funding and tender portal.

In 2023, EuroClio was partner in two projects within the Citizens, Equality, Rights and Values Programme (CERV) programme "European Remembrance Strand. These projects are based on unit costs. The unit costs are based on the number of participants and where the participants are from.

For the consultancies, what matters is the on time and complete delivery of the tasks.

2.8 Glossary

Accounting principles

The rules and guidelines that companies must follow when reporting financial data.

Accruals

Revenues that are earned or expenses incurred which have not yet been paid (back).

Appropriation

Set aside for use by. For example, using a positive result to increase the operating reserve.

Assets

Anything that you have that has monetary value.

Balance

The outcome of a comparison, for example the sum of income and costs.

Cash flows

The net amount of cash and cash-equivalents being transferred into and out of an organisation.

Contingencies

Costs that are unforeseen.

Co-financing

The practice were a project or event is financed by multiple donors.

Co-financing rate

The contribution that one donor is making to a project or event. It is usually expressed as a percentage of the total cost.

Credit (profit & loss)

Money coming in.

Creditor

A person or organisation to whom you owe money.

Consultancies

A paid service. Services can be: Reviewing curricula, developing standards for teachers, providing workshops or lectures.

Core funding

Financial support that covers the basic "core" organizational and administrative costs of an organisation including salaries of non-project staff, rent, equipment, utilities and communications.

2.8 Glossary

Debet (profit & loss)

Money going out.

Debtors

A person or organisation who owes money to you.

Depreciation

The decrease of value over time. This happens, for example, with computers and furniture. Using depreciation spreads the cost over time.

Depreciation Rate

The speed by which depreciation happens, usually measured by year. A depreciation rate of 33% assumes that something loses its value completely in three years time.

Disinvestment

This happens when something that still has value is no longer used or has been sold.

Earmarked

Money that needs to be spent on something specific. This money is reserved for this purpose only and cannot be freely spent.

Equity

Ownership of assets that have debts or liabilities attached to them. The value is the value of the assets minus the debts or liabilities.

Financial statements

Formal records of the financial activities and position of a person or organistaion.

F.t.e.

Full time equivalent. Used to describe the amount of staff that there would be if all staff members (exclusive trainees) would work full time.

Inventory

Goods that would be possible to sell.

Liabilities

Money that has been received, which still has to be spent, in order to be able to keep it.

Liquidity

The amount of money that can be spent at a particular moment in time. This includes: money on the bank, cash and creditcards.

2.8 Glossary

Operating Grant

A grant that can be used to cover the core costs of an organisation. Core costs include: Travel and stay by board, staff and ambassadors, bookkeeper costs, rent and computers.

Operating reserve

A financial reserve used to ensure that an organisation can continue to operate in the long term. It is needed for demonstrating sufficient financial capacity to certain donors, to prevent issues with liquidity, and to be able to pre-finance projects and events.

Partner project

A project led and applied for by another organisation, in which EuroClio is a partner organisation.

Petty cash

Cash kept on hand to pay for minor expenses, such as office supplies or reimbursements.

Project

A project, led and applied for by EuroClio. All projects have aims, expected results, a start and end date, and a donor.

Receivables

Debts owed for goods or services that have been delivered or used but not yet paid for.

Reimbursements

The action of paying someone back.

Remuneration

A reference to the combination of salary, options, bonuses, and other financial compensation.

Result

The balance of income minus expenditures.

Valuation

The process of determining the present value of an asset.

INDEPENDENT AUDITOR'S REPORT

To: the Board of EuroClio

Report on the audit of the financial statements 2023 included in the annual report

Our opinion

We have audited the financial statements 2023 of the European Association of History Educators (hereafter: Euroclio) EuroClio based in Hague.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of EuroClio as at 31 December 2023 and of its result for 2023 in accordance with the Guideline for annual reporting C1 'Kleine organisaties-zonder-winststreven' of the Dutch Accounting Standards Board.

The financial statements comprise:

- the balance sheet as at 31 December 2023;
- the statement of income and expenditure for 2023; and
- the notes comprising a summary of the accounting policies and other explanatory information.

Basis for our opinion

We conducted our audit in accordance with Dutch law, including the Dutch Standards on Auditing. Our responsibilities under those standards are further described in the 'Our responsibilities for the audit of the financial statements' section of our report.

By performing these procedures, we comply with the requirements of the Dutch Standard 720. The scope of the procedures performed is substantially less than the scope of those performed in our audit of the financial statements.

Description of responsibilities regarding the financial statements

Responsibilities of the Board for the financial statements

The Board is responsible for the preparation and fair presentation of the financial statements in accordance with the Guideline for annual reporting C1 'Kleine organisaties-zonder-winststreven' of the Dutch Accounting Standards Board. Furthermore, the Board is responsible for such internal control as the Board determines is necessary to enable the preparation of the financial statements that are free from material misstatement, whether due to fraud or error.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements. The materiality affects the nature, timing and extent of our audit procedures and the evaluation of the effect of identified misstatements on our opinion.



We have exercised professional judgement and have maintained professional skepticism throughout the audit, in accordance with Dutch Standards on Auditing, ethical requirements and independence requirements.

Our audit included e.g.:

- identifying and assessing the risks of material misstatement of the financial statements, whether due to fraud or error, designing and performing audit procedures responsive to those risks, and obtaining audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;
