Joint History Project I (2005)




The Joint History Project was launched in 1999, in an effort to change the way history is taught in schools across the Balkans. The founders – historians, diplomats, and philanthropists – were keen to draw on the education of youth as a way of approaching reconciliation in the region. The materials developed aim to present the same events from multiple perspectives, thereby revising ethnocentric history curricula, encouraging critical thinking, and celebrating regional diversity.

Learning Each Other's Historical Narrative (2006)



"Learning Each Other's Historical Narrative" focusses on teachers and schools as the key driver for changing deeply entrenched and polarised attitudes on both sides of the Palestinian-Israeli conflict. The goal of the project is to "disarm" the teaching of Middle Eastern history in Israeli and Palestinian classrooms. Unlike other projects that are limited to revising existing Israeli and Palestinian texts, this one engages teachers from both territories in a collaborative process.

A History to Open the Future: Modern East Asian History and Regional Reconciliation (2005)




"A History to Open the Future" was developed by a group of educators, citizens and scholars from China, Japan and South Korea. It was created in response to the Japanese government's 2005 approval of a secondary school textbook which the project participants felt was a distortion of Japanese history. The publication of a 'common' history of East Asia aimed to provide a foundation for reconciliation between the three countries, which have frequently clashed over how to approach controversial aspects of the region's history.






The aim of "Europe: Our History" is to provide Polish and German students with new approaches for learning history, particularly with regard to problem-oriented historical thinking and the role of history in the formation of identities. The project seeks to address the neglect of Eastern Europe in history curricula in Western Europe, while simultaneously integrating aspects of Western European history that are rarely covered in Polish curricula. European culture is presented in its complexity and diversity, based on the legacies of ancient Middle Eastern and Greco-Roman civilisations and those of Judaism, Christianity and Islam. This facilitates the study of European history from a broader perspective that challenges conventional East-West divides.




